

Dear Hydrographer,

- 1. In accordance with the revised procedures in force for the IHO Planning Cycle (see Reference A, *for non-Assembly Years*) and the consideration of financial statements for the previous year (See Reference B), this letter invites the Council Members to:
 - a. Evaluate the accomplishment of the preceding year's work program as presented in Part 1 (General) of the draft IHO Annual Report for 2020, and provide their comments at their earliest convenience; and
 - b. Approve the financial statements as presented in Part 2 (Finance) of the draft IHO Annual Report for 2020 and the recommendations of the Secretary-General based on his consultations with Chairs of the Finance Committee and Council, before the receipt of the external auditors report.
- 2. The external audit report of Price Waterhouse Cooper is not expected before the beginning of June 2021. Therefore, as a first step compromise, Council Members are invited to approve Part 2 (Finance) "as is", to enable the Secretariat to inform the Member States on the availability of the Annual Report for 2020 before summer.
- 3. After receipt of the external audit report, Part 2 (Finance) of the Annual Report for 2020 and the recommendations of the Secretary-General will be reviewed by the Chairs of the Finance Committee and Council at the Finance Committee Officers meeting. In accordance with Reference B (Paragraph 7), the report of this meeting will then be circulated among the Members of the Finance Committee for comments.
- 4. In the case that substantial comments and/or requests for corrections of Part 2 (Finance) will result from the activities explained under paragraph 3, an addendum to Part 2 (Finance) will be submitted to Council Members for voting and then incorporated into a revised version of the IHO Annual Report for 2020.
