- 1. In accordance with Reference A and B, this Council Circular Letter provides a revised provisional agenda for the 4th meeting of the IHO Council in Annex A as well as the associated logistic information on this remote event. - 2. As indicated in Reference B (Paragraph 20), the 4th Council meeting planned on 19 November afternoon, which coincides with Monaco National Day, will follow the 2nd Session of the Assembly and will be much shorter than usual. A provisional agenda and timetable is already available on the C-4 webpage for ease of reference, but it is likely that it may be amended at short notice to make sure that it meets the latest directions provided by the Assembly.

Participation of Member States

- 3. Member States occupying a seat on the Council in accordance with the composition approved by Decision A2/13 (See Reference C) and www.iho.int >... IHO Council > Basic Documents > Council Members (2020-2023) should be represented preferably by the Head of the Hydrographic Office, in accordance with Rule 5 of the Rules of Procedure of the IHO Council.
- 4. Member States that are not Members of the Council may participate in the meeting, but shall not be entitled to vote (See Article VI of the IHO Convention).
- 5. C-4 will be conducted as a remote event using the *gotomeeting* platform. For efficiency purpose and to ease the management of this short event, Members of the Council are therefore invited to consider registering no more than two representatives per delegation, while other participants are invited to limit their delegation to one person. These limitations do not include the Chairs of subsidiary organs requested to report to the Council.
