## MAINTAIN AND EXTEND S-4, DEVELOPMENT OF NEW (AND REVISED) SYMBOLOGY [A,D]

- S-4 Edition 4.9.0 published, March 2021
  - Available in English and French
  - Translation into Spanish in progress
- No active plans for significant restructuring or rewriting



#### IHO MAINTENANCE OF S-4 SUPPLEMENTARY PUBLICATIONS INT 1, 2 & 3 [E]

- International Hydrographic Organization
- INT1 [E1]
  - English version (UK), Edition 8, November 2020
    - Revision of UK version of Section V is ongoing. Consideration for international adoption pending. [E9]
  - French version (FR), Edition 7, April 2019
  - Spanish version (ES), Edition 6, April 2018
    - New Spanish version planned in 2022
- INT2, Edition 4, 2007 (NL)
- INT3, Edition 5, 2011 (UK)



## IHO MAINTAIN AND EXTEND S-11 PART A [B]

- Edition 3.1.0, February 2018
- No active plans for revision
- Section 200 will need to changes to support S-101



#### IHO BASELINE SYMBOLOGY PROJECT TEAM [E11, HSSC ACTION 13/43]

- PT formally established and TORs finalized
- Work in its early stages
- Requesting a HSSC to assign a domain for the symbol library in the IHO Registry
