Report of the Hydrographic Dictionary Working Group

PRINCIPAL ACTIVITIES AND ACHIEVEMENTS

- 1. Since 2020, due to the impossibility of conducting regular work, the WG activities have been shared between the departing Chairman and "Susie" LYU YuXiao, the Vice-Chair lady.
- 2. Harmonisation of S-32 HD / IHO GI Registry through the Concept Registry Domain Control Body has been continued under the responsibility of "Susie" LYU YuXiao. To this effect, an HD/GI Registry Workshop involving the IHO, the HDWG and participants from China MSA, and Korea KHOA's Registry team has been held in February 2022.
- 3. Following a Singapore initiative, a technical meeting was held on the 26th of April to discuss the introduction of the new "Hydrospatial" concept into the dictionary, the conclusion of which will be submitted to HSCC.
- 4. The 2-year HDWG Work Programme including a review of the current dictionary will have to be redefined to include a mechanism to update the dictionary and inform the Member States who maintain a national version.



HDWG / GI REGISTRY WORKSHOP

This workshop discussed the workflow of IHO Hydrographic Dictionary system and requirements for the Interface between Hydrographic Dictionary System and IHO GI Registry. It is confirmed after the workshop that Korea will develop the GI Registry to be available for connecting to HD system. And China will complete the linkage between the two systems according to the development progress.



HDWG / GI REGISTRY WORKSHOP

All new terms or modifications derived from Hydrographic Dictionary shall be registered in Concept Register in GI Registry and go through approval process conducted by Domain Control Body.



THE NEW "HYDROSPATIAL" CONCEPT

- The "Hydrospatial" concept has been submitted to HDWG by Dr Parry Oei, General Manager of the IHO Singapore Innovation and Technology Laboratory, and several other stakeholders.
- A general feeling is that "Hydrospatial" could be redundant with the enlarged Hydrography concept defined presently by the IHO. However, the 26th April VTC made it clear that "Hydrospatial" is not intended to be a Hydrography superset, but is an adjective which, associated with a term, e.g. data, could define a new IHO specific domain:



As a conclusion of the 26th April VTC, it was decided that the "Hydrospatial" advocates should undertake to develop a clear definition of the term in its Adjective form, for later consideration by the HDWG.



PROBLEMS OR OUTSTANDING ISSUES: GUIDING PRINCIPLES

- 1. The HD Guiding Principles have been set as the HSSC 12/58 decision, i.e. maintaining the Hydrographic Dictionary in its present encyclopaedic structure rather than downgrading it to a simpler glossary. This makes the Hydrographic Dictionary, using unspecific English language as a common working tool, a unique international reference encapsulating in equal footing the World's varied cultures.
- 2. HDWG membership will have to be reviewed and simplified to reflect the effective Members participation and increasing Asian shift. Confirmation of participation will be sought individually from Member States by the HDWG Chair.
- 3. If not defined carefully, introduction of the new concept: "Hydrospatial" could bring about substantial changes to the Hydrographic Dictionary (through the setting of new precedents). Given its importance, the HDWG will likely seek the advice of HSSC15 in making a final decision as to its inclusion.



- ➤ The difficulty is to maintain interest in a Working Group that has not met for two years
- Ongoing work includes fundamentals such as initiating other national versions (Korean, Arabic)
- To resume activities, recreate a dynamics, and acknowledge the increased role played by Asia Member states, confirm a faceto-face meeting in 2022 followed by a meeting in China when the pandemic is over.
