- The initial focus for the PT will be to develop a prioritised list of activities and seek review from CBSC and HSSC to validate this list, the intent is that this captures all known current and future needs and these will then be prioritised
- Focus will then shift to the identification of opportunities for recurring funding based on two scopes;
  - Scope 1 – existing and short-term options
  - Scope 2 – long term strategic options
- With these two elements work will move to analysis of the options reflecting tasks C, D and E which will allow a report to be submitted to IRCC17 (item F)

# PT Tasks

A	Identify the main IHO projects which would benefit from additional funding from alternative sources.
B	Identify and evaluate options for tactical recurring funding opportunities for each of the projects identified under (a). Consideration will be given to funding sources such as RENCs as well as external sources such as multilateral organizations, commercial partners, philanthropic organizations, etc.
C	Investigate and identify organizational, functional and resource requirements and gaps for the various types and/or sources of external funding.
D	Investigate and identify alignment and deviations from IHO rules, regulations and remit for the various types and/or sources of external funding.
E	Investigate and identify organizational, reputational, financial, legal and other risks to the IHO, Member States, beneficiaries and funders.
F	Finalize an agreed report of recommendations for C-9 endorsement and submission to A4.

A.1	Develop a prioritised list of activities that require funding.	H	PT1 actions A2 and A5 refer chair group to lead. The intent is for this to be a list of all potential activities so that a complete understanding of current and future needs is considered.
A.2	Seek review of the prioritised list from HSSC and CBSC to validate the activities identified and the assigned priority.	H	Engage with HSSC and CBSC to review and expand listing, RHCs to input via CB Coords. Seek to discuss at intersessional CBSC meeting.
B.1	Develop an initial list of potential short to medium term funding opportunities.	H	Finalisation depends on A.2 but work can commence in parallel.
B.2	Develop an initial list of longer-term funding opportunities.	M	Initial focus is on short to medium term options.
B.3	Analyse and prioritise the identified opportunities.	M	Dependent on B.1 and B.2
C.1	Assess the resource impact posed by progressing the identified opportunities.	M	Dependent on B.3
D.1	Assess any impact on IHO rules and procedures resulting from the identified opportunities.	M	Dependent on B.3
E.1	Develop a risk register to document the risks posed from these opportunities.	M	Approach is in line with ISO 9001 direction.
F.1	Prepare summary report and submit to IRCC17.	H	Report to be developed in Q1 2025.
F.2	Submit agreed report to C-9 for further submission to A-4.	H	Reflect IRCC inputs and submit for Council 9.
