## **Background**

- 1. The IHO Work Programme for 2018-2020 includes the following tasks related to outreach activities:
  - Task 1.3.1: Promote the IHO through publicity and public relations initiatives
  - Task 1.4.4: Conduct biennial IHO stakeholders' forums
  - Task 2.1.6: Provide technical outreach, advice and guidance in relation to IHO standards, specification and publications
  - Task 2.3.5: Provide advice and guidance to other organizations developing S-100 based Product Specifications
  - Task 2.7.1: Organize the biennial ABLOS Conference
  - Task 3.3.7: Organize, prepare and report on a Capacity Building Stakeholders' Forum
  - Task 3.6.7: Contribute to outreach and education about ocean mapping. Increase understanding of the importance of hydrography and interest in following ocean mapping as a career
- 2. This paper reviews the status of relations with stakeholders and provides the preliminary list of events that could offer opportunities to interact with stakeholders in 2018. It considers which events would justify the involvement of representatives from IHO Member States and/or from the Secretariat, subject to the availability of resources.

## Status of Relations with Stakeholders

- 3. Since HSSC-9, no new cooperative arrangements have been established.
- 4. In addition, to the International Organizations that have Observer status, the IHO maintains an "External Stakeholders' contact list" (see Home > External Liaisons > External Stakeholders; direct link: <a href="IHO\_External\_Stakeholders\_List">IHO\_External\_Stakeholders\_List</a>).

### IHO Stakeholders' Forum and related activities

- 5. No IHO-led events engaging IHO Stakeholders took place during the HSSC inter-sessional period.
- 6. The Committee is invited to consider the development of proposals to plan an IHO Stakeholders' Forum in 2019, in accordance with the IHO Work Programme for 2018-2020. In accordance with Action HSSC9/57, it is also invited to consider the need and possibility of arranging an ECDIS Stakeholder's Forum in 2019, either in conjunction with HSSC-11 or later.

#### Other Events in 2018

- 7. Annex A lists events planned in 2018 of which the IHO Secretariat is aware and which could offer opportunities to interact with stakeholders, subject to the availability of resources. The Secretariat views on IHO participation are provided.
- 8. The Committee is invited to review how the IHO might be represented in those events that are considered relevant.

## Analysis/Discussion

9. The list of potential stakeholders events have been presented for a number of years to HSSC and IRCC and the usefulness of the document is debateable. It very rarely generate any discussion and limited inputs are received. The list of stakeholder events remains a HSSC document and is not displayed anywhere else, which may also account for the limited feedback and inputs. Upcoming public events are posted on the IHO website and some of these events feature in the list of the stakeholder events, but only when there is a request from organisers to publicise the event.

# **Conclusion and Recommendations**

10. The continued production of a list of potential stakeholder events can only be justified if the information is not only a Secretariat view on matters of interest with limited or no inputs from member states. The maintenance of the list in its current form is from public source information and a fairly laborious task to maintain and update. The lack of visibility of the information may be addressed by means of the IHO Calendar where not only the event can be displayed, but also attendance. Visibility on the IHO Calendar will also encourage wider participation in the identification of stakeholder events.

## **Action required of HSSC**

- 11. The HSSC is invited to:
  - a. **note** this report;
  - b. **consider** the development of proposals to plan an IHO Stakeholders' Forum in 2019, in accordance with the IHO Work Programme for 2018-2020;
  - c. **consider**, in accordance with Action HSSC9/57, the need and possibility of arranging an ECDIS Stakeholder's Forum in 2019, either in conjunction with HSSC-11, or later.
  - d. **consider** the relevance of the list and its continued existence in current or different format.
  - e. **review** the list of other related events in 2018 and how the IHO might be represented in those events that are considered relevant; and
  - f. take any other actions as appropriate.
