#### Subject: 15<sup>th</sup> SAIHC Agenda Explanatory Note

Dear SAIHC Colleagues,

Please find attached the agenda for our upcoming meeting.

To ensure that we have a successful and productive meeting, I would like to encourage you to consider in advance the following six key points:

- Seminar on Raising Awareness of Hydrography this will set the scene in ensuring uniform understanding of the obligations and the governance requirements of providing a national hydrographic service. We should consider how SAIHC can best support coastal states in meeting international obligations. Please be prepared to contribute with your experience of hydrographic service best practice and highlight challenges faced, and provide feedback on your experience of the Seminar in the Capacity Building agenda item 12.2.1.
- 2. **Regional MSDI** desires for a SAIHC regional MSDI will be discussed. This could be a background consideration throughout the meeting. I will be very interested to hear your opinion on how an MSDI could be established and what you hope it would deliver for the region.
- 3. **INT Chart Coordination Working Group** this separate meeting aims to coordinate the allocation of production responsibilities to ensure that both paper and electronic chart coverage supports ships engaged in international voyages. Please review your current and future capability in INT chart and ENC production. Please also consider the IRCC10 recommendations from WENDWG.
- 4. **National Reports** this is an important part of the meeting. If you are not yet a Member of IHO, it would be most helpful if you could provide an update on your intentions to join IHO, which includes any impediments or issues preventing membership, in your National Report, in accordance with SAIHC14 Action 15. I look forward to your input to enhance ongoing cooperation throughout the SAIHC region.
- 5. **Capacity Building** we will jointly develop a SAIHC CB Strategy to augment the SAIHC CB Plan (2018-2020). Please consider your requirements and contributions.
- 6. IRCC10 Action 3 this review of draft IHO Resolution 2/1997 as amended Establishment of RHCs (which will be circulated separately, when available) is important as it directly impacts on our Commissions Status and ultimate relationship with the IHO as a whole. It will be a discussion point at the next Council Meeting and it would be important to ensure that the views of our Commission are represented.
